MAKING LIFE MORE AFFORDABLE

THE MIDDLE CLASS TAX CUT SAVING FAMILIES UP TO \$840 A YEAR

Effective, July 1st, 2025, our new federal government is **reducing personal income tax rate**, saving families up to \$840 per year.

22 MILLION CANADIANS



Are expected to benefit from this measure. This reduced tax rate is **applicable to an individual's taxable income, regardless of income level.**

GST RELIEF FOR 1ST-TIME HOME BUYERS

To lower the cost of buying a new home for young Canadians, **GST is being eliminated** for first-time home buyers up to \$1 million; GST is reduced for homes up to \$1.5 million.

UP TO \$50,000 IN SAVINGS



This measure is expected to deliver **\$3.9 billion in tax savings** to Canadians over five years, starting in 2025-26.

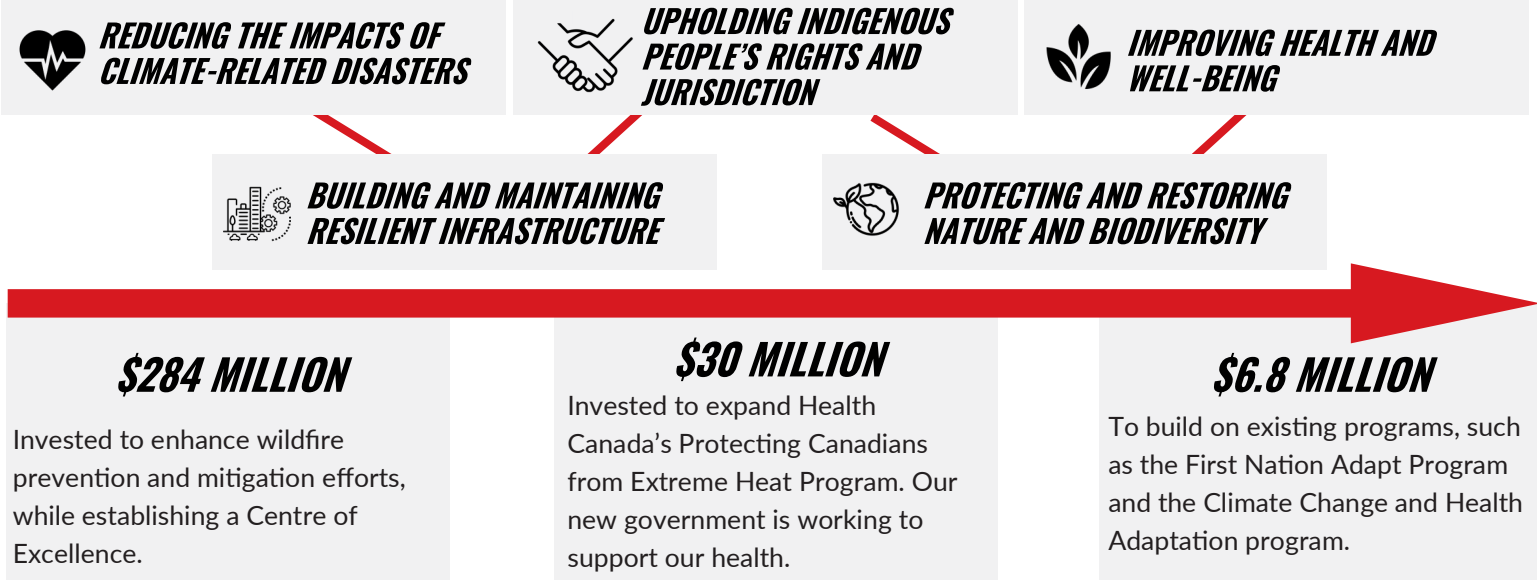

CANADA DISABILITY BENEFIT (CDB)

 Be a resident of Canada;

 Be approved for the Disability Tax Credit;

 Be between the ages of 18 and 64;

 Have filed an income tax return for the previous tax year.

 Be one of the following:

- A Canadian Citizen.
- A Permanent Resident.
- A Protected Person.
- A temporary resident who has lived in Canada for the past 18 months.
- Registered under the Indian Act.
